

What Happens If KLM Cancels Your Flight? A Complete Guide for U.S. Travelers

European Union Regulation EC 261/2004

- **Assistance:** If your flight is canceled and you are stranded, KLM must provide reasonable assistance, such as meals, refreshments, and hotel accommodations (if necessary). Transportation to and from the hotel is also provided.

U.S. Department of Transportation (DOT)

- **Full Refund:** U.S. passengers are entitled to a full refund if KLM cancels a flight. This applies even to non-refundable tickets.
- **Compensation:** Unlike the European Union, the U.S. does not mandate compensation for cancellations unless the airline is responsible for the delay, such as when the airline fails to notify you in advance of the cancellation.

Step 2: Immediate Actions to Take if KLM Cancels Your Flight

When KLM cancels your flight, the airline is responsible for informing you as soon as possible. However, if you find out that your flight has been canceled and you haven't received a notification, here's what you should do:

1. Confirm the Cancellation

Before you do anything, it's essential to confirm that your flight is, in fact, canceled. You can:

Full Refund for Canceled Flights

KLM is required to offer a full refund if they cancel your flight, regardless of the reason. In many cases, you can receive a full refund within **7-14 business days** of cancellation, depending on the payment method.

Compensation for Canceled Flights (EU Regulation 261/2004)

If KLM cancels your flight within 14 days of departure and it's within their control, you may be entitled to financial compensation. This compensation varies based on the distance of your flight:

- **Short-haul Flights (up to 1,500 km): €250** in compensation.
- **Medium-haul Flights (1,500 km to 3,500 km): €400** in compensation.
- **Long-haul Flights (over 3,500 km): €600** in compensation.

Meal Vouchers, Accommodations, and Transport

If your cancellation results in a significant delay and you are stranded at the airport, KLM must provide assistance, including:

- **Meals and Refreshments:** If your wait exceeds several hours, KLM will offer meal vouchers for meals and snacks. The number of vouchers will depend on the length of your delay.
- **Hotel Accommodation:** If you are delayed overnight, KLM will provide you with hotel accommodation and transport to and from the hotel, at no additional cost.
